Dear Mr. Ekstedt:

The purpose of this letter is to support the efforts and the purpose of the Washington State UTC Grant to reduce accident/incident frequency and severity at both public and private railroad crossing; and to reduce pedestrian trespassing and the frequency of trespassing related death and injuries along railroad rights-of-way.

One block north running parallel to the White Swan High School and the Mt. Adams Middle School campus is a railroad line. The railroad line carries wood products manufactured by two large industries in White Swan. The industries are Yakama Forest Products and Jeld-Wen. The railroad line is also located across the street from our off-campus portable classroom site.

During the early morning school start time and afternoon dismissal time, there are approximately 150 students that walk across the railroad lines to get to and from school. It has been estimated by our Transportation Director Don Jensen that at least 500 students and community members cross the tracks in a day.

On behalf of the Mt. Adams School District, I support a safety improvement that would protect our community members and students from pedestrian trespassing related deaths and injuries along the railroad right-of-way that is bordering our White Swan campus.

This is the Yakama Nation's Letter of support for the County of Yakima, State of Washington's proposal to install a security fence along the railroad in White Swan, Washington. This fence will be installed between Curtis Road and Signal Peak Road.

White Swan is a basic small community with one store and one school and a rail line in between. The rail line can have approximately twelve (24 trips) trains going to the White Swan lumber mill each day. Students walk to the store at all hours using many different student made crossings.

It is the goal of the Yakama Nation to save student lives. We appreciate the assistance and cooperation Yakama County will provide in accomplishing our goals in optimizing student safety.
