AMENDMENT TO PURCHASE AND SALE
OF CORPORATE STOCK AGREEMENT

1. On March 20, 2007, NICHOLAS L. THOMPSON, a single man, DALE E. NICHOLS, a single man, and KATHRYN E. KASER, a single lady, hereinafter referred to collectively as "sellers", and PAUL AND MELINDA CHRISTENSEN, husband and wife, hereinafter referred to as "buyers," entered a stock purchase agreement, for the stock of Oasis Water Corporation, a Washington corporation. The parties wish to now amend the agreement, at the insistence of the Washington Utilities and Transportation Commission, to remove Oasis Water Corporation's real property as collateral for the debt owed under the stock purchase agreement. Therefore, based upon mutual consideration and agreement, the parties agree as follows:

2. Paragraph 3 of the stock purchase agreement shall be and is hereby deleted. The real property of Oasis Water Corporation shall not be used as collateral for the debt. Oasis Water Corporation and K. Kaser Company, Inc., shall execute and record a revocation of the mortgage signed on March 30, 2007, and recorded on April 5, 2007. K. Kaser Company, Inc., is the mortgagee under the mortgage.


3. As collateral for amounts owed, the sellers shall have a secured interest in the corporate stock of Oasis Water Corporation. Until the purchase price is paid in full, all shares of

stock issued shall be marked "security for purchase price debt." Buyers, as shareholders, officers, and directors of Oasis Water Corporation, shall not issue any additional stock until the purchase price is paid in full. Buyers, as shareholders, officers, and directors of Oasis Water Corporation, shall not take any action to divest Oasis Water Corporation of the real and personal property that the corporation currently owns until the purchase price is paid in full.

3. In all other respects, the March 20, 2007, stock purchase agreement shall remain in full force and effect.
