1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: October 1, 2007.

3. The temporary 1.46% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of June 2007, July and August 2007, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of September, October and November 2007.
