The company requests Commission approval to amend its filed Tariff Number 9 on Less the Statutory Notice to include a Special Fuel Surcharge Tariff Supplement to recover the rising cost of fuel. Fuel index prices have increased from \$1.9274 per gallon for the base period to \$4.6325 per gallon current price. Proposed changes are to add a Special Fuel Surcharge #9 in the amount of 7.03%.

1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: September 1, 2008.

3. The temporary 7.03% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of May, June and July 2008 to be collected from customers as follows:
4. This Supplement No. 9 cancels Supplement No. 8.
5. For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of September, October and November 2008. Customers who are billed quarterly for services – One month in arrears, current month and one month in advance:
