1. The Commission finds good cause to support the request and authorize the proposed changes to become effective with Less Than Statutory Notice on: October 1, 2008.

3. The temporary 1.39% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of July 2008 and August 2008, to be collected from customers as follows:
