3. The temporary 5.20% fuel surcharge in all rates and charges is the result of increased fuel costs incurred by the company during the months of June, July and August 2008, to be collected from customers as follows:

For customers who are billed monthly for services in arrears, the fuel surcharge applies to all services provided in the months of October, November and December 2008.

Customers who are billed quarterly for services – one month in arrears, current month and one month in advance:
