Item 51 – Restart Fees

If service is stopped due to customer delinquency and subsequently restarted, a restart fee of \$15.00 (A) will be assessed.

Item 52 – Redelivery Fees

Containers: The carrier will assess a charge of \$ 18.50 for redelivery when a customer requires maintenance or cleaning on a container at customer's request.

Drop Boxes: The carrier will assess a charge of \$ 36.85 for redelivery when a customer requires maintenance or cleaning on a drop box at customer's request.

Garbage Toter: The carrier will assess a charge of \$20.00 (A) for redelivery when a customer requests a change in garbage toter service more than one time in a 12 month period, or requests a replacement container at the convenience of the customer.

Organic Waste Toters: The carrier will assess a charge of \$15.00 for redelivery when a customer stops yard waste service and subsequently restarts within a six month period.

Residential Recycling: The carrier will assess a charge of \$16.80 for redelivery if recycling toter is replaced at the request of the customer.
