Description of amendment: reciprocal compensation

The amendment amends an adopted interconnection agreement that is currently pending before the Commission, set for the September 25, 2008 Open Meeting. The adopted agreement was originally approved by the Commission on July 26, 2006 in Docket No. UT-063046 between Company A and Company C, Ymax Communications Corp.

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B's signature on the amendment, Company A believes that Company B agrees with these representations.
