
Tina Leipski and the WUTC:

# **LABOR READY**

This Agreement is made by and between TrueBlue, Inc. on behalf of its Labor Ready brand subsidiaries in the states in which service is provided (herein "Labor Ready") and City Movers (herein "Customer").

Labor Ready has provided a good faith rate quote agreement between Customer and will secure such proposal for 30 days from submittal date of 6/20/2009 and will expire (06/30/10)

Customer agrees to pay Labor Ready a fee as set forth above for each hour worked by a worker provided to Customer by Labor Ready pursuant to this Agreement. Billing time commences upon the worker's arrival at the requested time.

Labor Ready's Markup Rate includes: Worker's Compensation coverage, applicable payroll taxes, profit, insurance and recruiting/administration costs.

## Adjustment of Pay Rates

Employee Pay Rates shall be paid at the minimum wage rate for the state in which service is provided or the wage rate agreed to by and between Labor Ready and Customer. Where certified payroll is required the employee Pay Rates shall be paid at the hourly prevailing wage rate included on the rate sheet supplied by Customer.

## Payment Terms

Labor Ready's Payment terms are net thirty (30) days from date of invoice. Labor Ready work week consist of Saturday through Friday. In the event Customer fails to pay any proper invoices as and when due Labor Ready shall have the right to immediately terminate the agreement.

## **Sales Tax**

Sales tax for goods and services shall apply in the following states and / or countries: HI, CT, NM, OH, PA, SD, NY, WA, WV and Canada.

## **Minimum Charge**

Labor Ready has a four (4) hour minimum charge for our temporary services, and should the temporary worker perform less than four hours of work, a four-hour charge will still apply. In the event Labor Ready is not informed of an order cancellation prior to dispatch a two (2) hour show-up fee shall apply per person (except for Canada, RI and MA in which the fee shall be 3 hours per person and IL, NY and PR where the fee shall be 4 hours per person); and any location in which workers travel more than 70 miles one way a (4) hour show-up fee shall apply per person.

## **Transportation Fees**

Should Customer require temporary staff to provide their own transportation to a jobsite location in which the nearest Labor Ready office is in excess of 20 miles a transportation fee may apply.

## **Overtime**

Overtime charges are applicable to overtime hours worked. Overtime charges will be billed at a multiplier of 1.3 times the billing rate. Double Time charges will be billed at a multiplier of 1.7 times the billing rates. Overtime and Double Time laws vary by state contact your Labor Ready servicing branch for details.

## **Safety**

Customer shall provide any safety equipment or other devices necessary for the work to be performed.

Customer agrees that it will not, without the prior written consent of Labor Ready, utilize Labor Ready workers for excavation where proper shoring and protection are not provided, for any work on ladders or scaffolding, or as the member of the crew of any vessel or in maritime work upon the navigable waters of the United States which might be subject to the United States Longshoremen's and Harborworker's Compensation Act, or the Jones Act.

Customer agrees to comply with all applicable laws and ordinances relating to health and safety, and in particular, agrees and undertakes to include Labor Ready workers, while in the care, custody and control of Customer, in Customer's Safety and Health Program, if applicable, (e.g., Injury and Illness Prevention Program, Accident Prevention Program) which would cover Customer's employees in the performance of similar work and to provide Personal Protective Equipment ("PPE"), clothing or devices necessary or required by law for any work to be performed or used by Customer's employees in the performance of similar work. Customer agrees to provide site specific safety orientation and training to all Labor Ready workers prior to the start of work.

## **Service Guarantee**

Our service guarantee is our Presidential commitment to our customers. Labor Ready will honor a 2 hour guarantee based on your dissatisfaction of our temporary employee within the first two hours of their work schedule.
