Dear Mr. Goltz:

On behalf of McLeodUSA Telecommunications Services, Inc. (“McLeodUSA”), and in connection with the matter referenced above, please find enclosed a Washington Secretary of State certification of McLeodUSA’s conversion from an incorporated company to a limited liability company. Further, the *pro forma* intracorporate reorganization involving McLeodUSA, which was described in previous correspondence to the Washington Utilities and Transportation Commission (the “Commission”) in connection with this matter, has been consummated. The *pro forma* intracorporate reorganization occurred on March 1, 2010. Through the reorganization, McLeodUSA has become an indirect wholly-owned subsidiary of PAETEC Holding under the PAETEC Corp. and PAETEC Communications, Inc. subsidiaries. Previously, McLeodUSA was held by PAETEC Holding through different intervening parent companies; namely, McLeodUSA Inc. and McLeodUSA Holdings, Inc., former subsidiaries of PAETEC Holding.

We understand from previous correspondence from the Commission that confirmation of (1) the Washington Secretary of State’s certification of McLeodUSA’s corporate form conversion, and (2) the execution of the *pro forma* intracorporate reorganization, was the remaining information that the Commission needed to process the docket referenced above. Please let us know if you need any additional information.


