Voicecom Telecommunications, Inc. ("Voicecom"), Voicecom Telecommunications, LLC ("Voicecom Operating") and Amvensys Telecom Holdings, LLC ("Amvensys"), through the undersigned counsel, hereby notify the Washington State Utilities & Transportation Commission (the "Commission") that on May 2, 2011 Voicecom Operating became an indirect, wholly-owned subsidiary of Amvensys.

As explained in previous correspondence to the Commission, although Amvensys' acquisition of Voicecom resulted in a change in the ultimate ownership and control of Voicecom Operating, the acquisition did not involve a transfer of assets or customers and did not result in any change in the rates or terms and conditions of service provided by Voicecom Operating pursuant to its existing authorization.<sup>1</sup>


