- (4) Be kept and maintained in a manner that retains the legibility;
- (5) Markings may be painted on the commercial motor vehicle or may consist of a removable device.

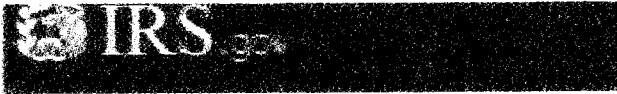
