

- X You need to have a USDOT number. You can obtain one online at www.fmcsa.dot.gov/online-registration or you can contact (360)596-3810 for assistance
- X The Certificate of Liability Insurance we feed with your application is acceptable. We just need to verify your cargo insurance filing.
- Normally, we issue household goods permits with statewide authority. You have indicated you only want King and Pierce Counties. Please confirm those are the only counties you actually want.
