As discussed in our conversation today, the new pipe to be installed on the 16" Fredonia Transmission Line Casing replacement project will be 16" x 0.375" Grade 56 API 5L line pipe with fusion bonded epoxy coating.

All fittings (elbows, etc.) will be 16" x 0.375" WPHY-56 per ANSI 16.9 to meet or exceed the design rating of the pipe

With these materials, %SMYS = 19.05 at a MAOP of 500 psig. Please update the commission order documents to reflect this change.
