360networks Corporation (“360-Parent”), 360networks (USA) inc. (“360networks”) and Zayo Group, LLC (“Zayo”) (collectively, the “Parties”), by undersigned counsel, notify the Commission that on December 1, 2011, the Parties completed the transfer of indirect control of 360networks to Zayo as described in the Parties’ letter filed in this docket on November 3, 2011 (the “Notice”). The Parties note that the transfer of certain wholesale long distance and local voice and switched access facilities and services currently provided by 360networks to Zayo’s affiliate, Onvoy, Inc., as described in footnote 2 of the Notice, has not yet occurred.
