Dear Ms. Dortch:

On December 7, 2012, XO Communications, LLC, ("XO Communications"), by its attorneys and pursuant to section 63.71 of the Federal Communications Commission ("Commission") rules, 47 C.F.R. § 63.71(a), filed a Section 63.71 Application for the discontinuance of its Consumer Dial and Corporate Dial interstate domestic dial-up ("Dial Up") services. This letter is submitted to amend XO Communications' initial filing by specifying the geographic areas affected by the discontinuance.

The Section 63.71 Application stated XO Communications would be discontinuing selected Dial Up service throughout its nationwide service territory. By this amendment, XO Communications clarifies that it is discontinuing the offering of the Dial Up services in the following states: Alabama, Arizona, California, Colorado, Connecticut, Delaware, Florida, Georgia, Hawaii, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Maryland, Massachusetts, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Jersey, New Mexico, New York, North Carolina, Ohio, Oklahoma, Oregon, Pennsylvania, Rhode Island, South Carolina, Tennessee, Texas, Utah, Vermont, Virginia, Washington, Wisconsin, Wyoming and the District of Columbia. XO does not currently offer the service in states other than those identified above.

The undersigned counsel also confirms that the December 7, 2012 Section 63.71 Application was sent to the correct address for the Office of the Governor for the State of Louisiana.




