Re: Numbering waiver for Camas Rate Center

Dear Mr. King,

Frontier Communications Northwest Inc. requests the Washington Utilities and Transportation Commission to direct the Pooling Administrator (PA) to provide Frontier with one thousand number block to satisfy the requirement for Fisher Investments located in Camas, WA in the Camas Rate Center, NPA 360, LATA 672, OCN 4324 switch CAMSWAXXDS1.

The customer requests one thousand number block as they are moving their corporate headquarters to Camas, WA and this is a new PRI. Due to the use of a PBX system, they are unable to use NXX codes starting with "9". Therefore, the customer requests a waiver to obtain 1,000 consecutive numbers with a preferred assignment of XXX-XX8-5XXX.

The waiver request is made because Frontier's request for one thousand number block was denied by the PA because the serving central office does not meet the six (6) "months to exhaust" or utilization criteria. The PA requires the "months to exhaust" be less than or equal to six (6) months and the service central office is currently at 153 months. Also, the percent utilization is currently at 24.651%, which is less than the 75% utilization required by the FCC.

The Washington Commission has the authority to review the PA's criteria and request a waiver when appropriate, in this case a waiver request for the months to exhaust and utilization criteria. Frontier requests the commission instruct the PA to release the numbering resources necessary to meet the needs of this Frontier customer.

Frontier requests approval of this waiver request with an effective date of November 2, 2013 or as soon as possible. The Commission's waiver request must be submitted with the company's application to the PA for the numbering resources needed for deployment of service to this customer.
