- On April 25, 2014, Charter Bus Seattle, LLC, (Charter Bus Seattle, LLC), filed with the Washington Utilities and Transportation Commission (Commission) an application requesting authority to provide charter and excursion carrier service in the state of Washington under RCW 81.70.
