Re: Power Cost Only Rate Case ("PCORC") Filing of Puget Sound Energy, Inc. Advice No. 2014-17 - Electric Tariff Filing

Dear Mr. King:

Pursuant to RCW 80.28.060, WAC 480-80-101 and -105, the Power Cost Adjustment Mechanism (PCA Mechanism") set forth in Exhibit A to the Settlement Stipulation approved by the Commission in its Twelfth Supplemental Order in Docket Nos. UE-011570 and UG-011571 (consolidated), and the agreement to file a Power Cost Only Rate Case ("PCORC") approved by the Commission in its October 23, 2013 order in Docket Nos. UE-130583, UE-130617, UE-131099 and UE-131230, Puget Sound Energy, Inc. ("PSE" or "the Company") hereby seeks the Commission's approval to revise its Power Cost Rate reflected in Schedule 95, in order to reflect decreases in the Company's overall normalized power supply costs.

This filing proposes revisions in the following electric tariff sheets:

The Purpose of This Filing

The power cost baseline rate that is currently embedded in PSE's electric rates was established through the Commission's Order 06 in PSE's last PCORC in Docket No. UE-130617 which was consolidated with Docket Nos. UE-130583, UE-131099 and UE-131230. The Company's PCORC filing submitted with this letter seeks approval of a new, adjusted Power Cost Rate based upon projected normalized power costs for the proposed rate year for this PCORC: the 12-month period beginning December 1, 2014. Overall, PSE proposes in this filing to decrease electric rates by \$9,554,847 or an average decrease of approximately 0.456%, in order to pass through reductions in projected power costs the Company expects to face during the rate year.

Overall, this proposal represents a revenue decrease of \$9,554,847 or 0.456% reduction for customers. All rate schedules for electric service, except transportation customers, are affected by the change; most will experience a small decrease, and a few lighting customers with smaller sizes of street lights will experience no change. For example, the typical residential customer using 1,000 kWh per month will experience a decrease of forty-seven cents (\$0.47) per month.

Confidentiality Protections and Procedural Matters

PSE requests that the Commission issue its standard protective order. As is evident from PSE's filing, the Company has marked several pages "confidential." The documents designated as "confidential" are currently protected from any further disclosure by the Commission or the Office of the Attorney General pursuant to RCW 80.04.095 and WAC 480-07-160. However, in order to permit appropriate review of the materials by experts for the Commission Staff and/or Public Counsel, a protective order should be entered in this proceeding as soon as possible.

Second, as provided in the Commission's order in Docket Nos. UE-072300 and UG-072301 (consolidated) the duration of a PCORC proceeding is limited to six months. PSE respectfully requests an expedited schedule that allows this case to conclude within the sixth month period. PSE requests that the Commission issue a final order in this case by November 24, 2014 to allow rates to go into effect December 1, 2014.

Notice of PCORC Filing

The tariff sheets described herein reflect an issue date of May 23, 2014, and an effective date of June 23, 2014. Posting of proposed tariff changes, as required by WAC 480-100-193, is being made by posting the proposed tariff sheets on the PSE web site immediately prior to or coincident with the date of this transmittal letter.
