**RE: Notice of Consummation of Transfer of Control of Grasshopper Group, LLC to Citrix Systems, Inc.**

Dear Sir or Madam:

Grasshopper Group, LLC ("Grasshopper" or "Transferor") and Citrix Systems, Inc. ("Citrix" or "Transferee") (collectively the "Parties"), by undersigned counsel, hereby notify the Washington Utilities and Transportation Commission ("Commission"), of the consummation of the transfer of control of Grasshopper to Citrix ("Transaction") on May 19, 2015. Grasshopper was authorized to provide competitive intrastate interexchange telecommunications services within the State of Washington on December 12, 2009.<sup>1</sup> It is the Parties' understanding that prior Commission approval of the transaction was not required. The Parties previously notified the Commission of their intent to consummate the transaction on April 6, 2015.
