<p><u>Item 105 -- Multi-family Service</u></p> <p>Rates below apply in the following service area: <u>Thurston County Below 142nd Ave</u></p> <p>Rates in this item will apply to duplexes, apartment complexes containing 2 or more units, mobile homes and courts, condominiums, etc., where service is billed and paid by the residential property owner or manager.</p> <p><u>Units and frequency of service:</u> <i>Units of eight or fewer residences</i> will be served with wheeled approximately 96 gallon carts which will be collected bi-weekly except for glass which will be picked up in a customer-provided container and collected every four weeks. Complexes will receive one cart per residence unless otherwise requested by the property owner/manager.</p> <p><i>Units of greater than eight residences</i> will be serviced with containers ranging from approximately 96 gallons to two yard containers with glass collected in separate containers. The company will coordinate with the property owner/manager to provide adequate capacity to collect available material. The hauler may provide weekly collection of deemed necessary by both the landlord and hauler.</p> <p><u>Materials to be collected are as follows:</u> <u>Cardboard:</u> corrugated cardboard and Kraft paper, including unbleached, unwaxed paper made with a ruffled ("corrugated") inner liner. <u>Metal Cans:</u> tin-coated steel cans and aluminum cans, excluding aerosol spray cans. <u>Mixed-waste paper:</u> clean and dry paper, including: glossy paper; magazines; catalogs; phone books; cards; laser-printed white ledger paper; window envelopes; paper with adhesive labels; paper bags; non-metallic wrapping paper; packing paper; glossy advertising paper; chipboard, such as cereal and shoe boxes; juice boxes; and milk-style cartons fo the refrigerated variety (non-refrigerated products contain aluminum linings). <u>Newspaper:</u> printed ground wood newsprint, including glossy advertisements and supplemental magazines that are delivered with the newspaper. <u>Plastics:</u> Round dairy containers, such as yogurt and margarine tubs. Bottles and jars #1-7: primarily polyethylene terephthalate (PET - #1), such as soft drink, water, and salad dresing bottles; and high-density polyethylene (HDPE- #2) such as milk, shampoo, or laundry detergent bottles; but including any bottle with a neck narrower than its base. <u>Glass:</u> bottles and jars of all colors.</p> <p><u>Rates:</u> Rates per available residential unit: \$4.97 per month. Item 105 -- Multi-family Service (In Lewis County designated RSA-1)

Service is provided as designated in Lewis County Ordinance No. 1196

Rates in this item will apply to duplexes, apartment complexes containing 2 or more units, mobile homes and courts, condominiums, etc., where service is billed and paid by the residential property owner or manager.

Units and frequency of service:

Units of four or fewer residences will be served with wheeled approximately 96 gallon carts which will be collected bi-weekly. Complexes will receive one cart per residence unless otherwise requested by the property owner/manager.

Units of greater than four residences will be serviced with wheeled carts approximately 96 gallons which will be collected bi-weekly. Since service is voluntary, complexes will only pay for the number of requested containers.

Materials to be collected are as follows:

Newspaper, cardboard, aluminum cans, cardboard milk and juice cartons, magazines, paperboard, tin cans, plastic bottles and jugs, and mixed waste paper.

Rates:

Complexes of four or fewer units will be charged \$5.42 per resident regardless of participation. Complexes greater than four units will be charged \$5.42 per container on a voluntary basis. In addition to the above rates customers will receive a commodity price adjustment of (\$.85) (R) credit per chargeable unit.

Implementation Period: Rates will be charged within 15 days of customer either receiving containers or being offered service. All customers will be offered service by April 1, 2008.
