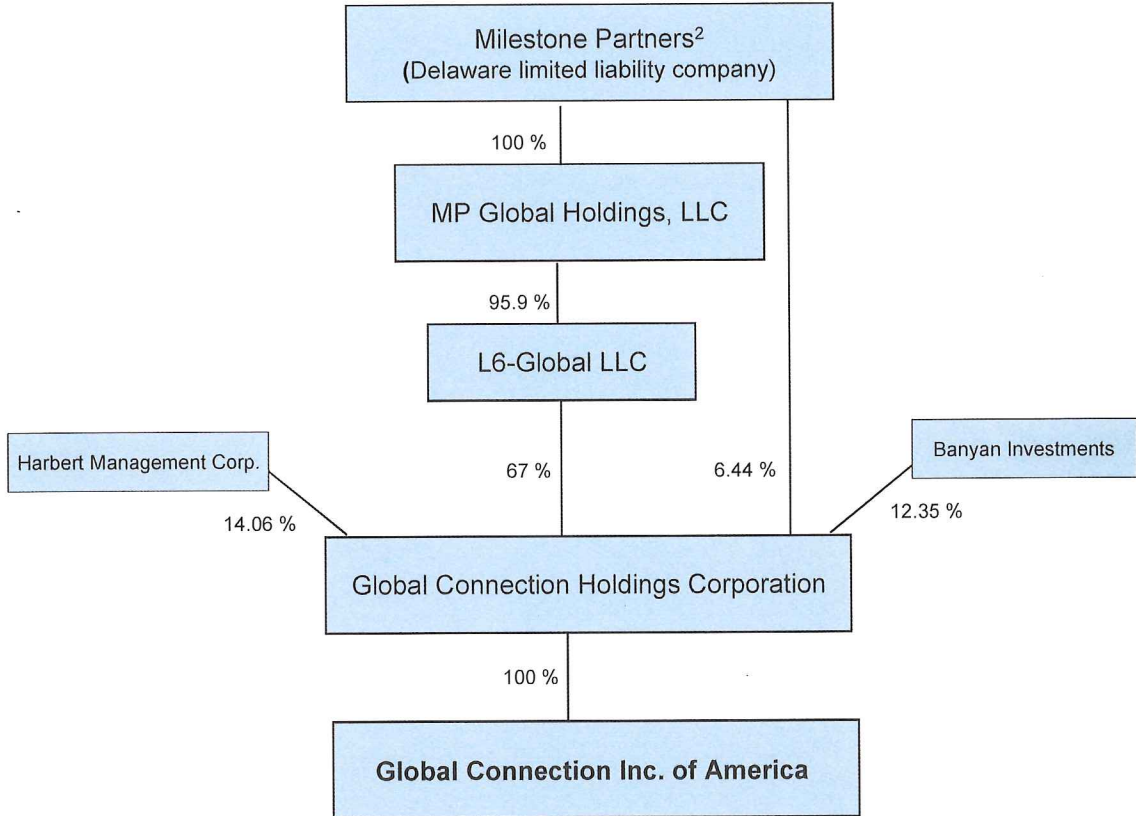

Corporate Structure Diagrams

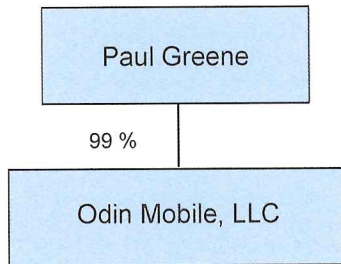
**Global Connection Inc. of America

(Interests $\geq 10\%$)¹**



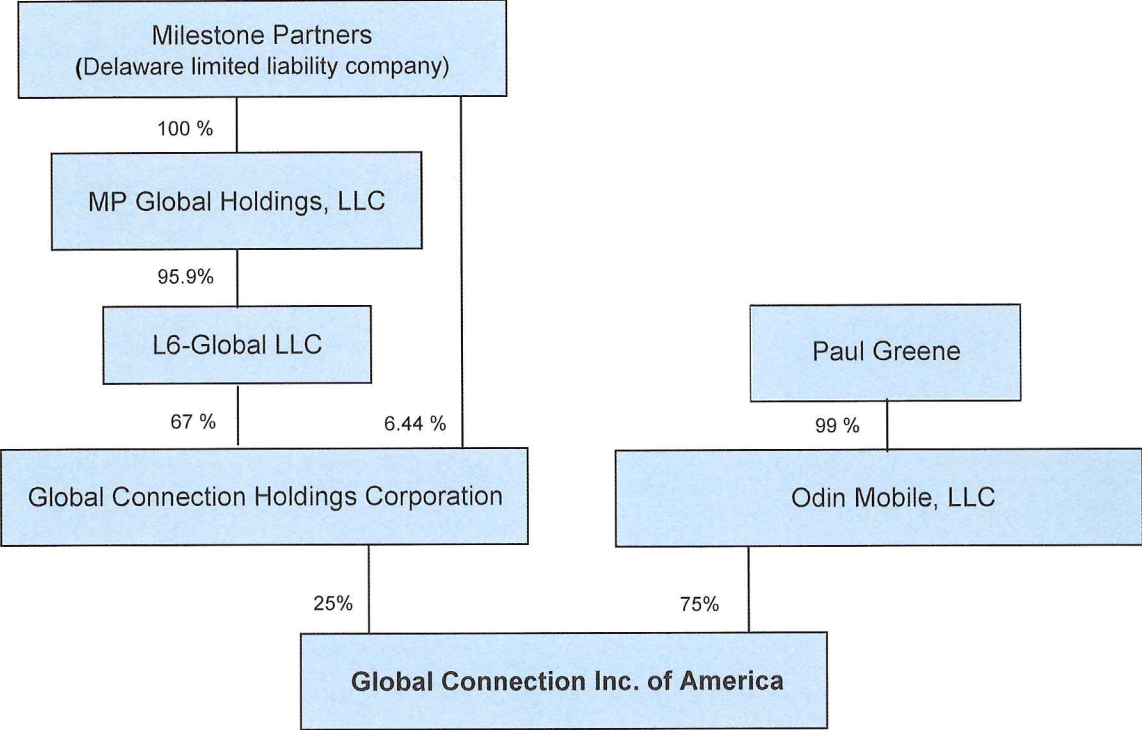
