## RE: Advice 17-09—Schedule 93—Annual Decoupling Revenue Adjustment

Pacific Power & Light Company (Pacific Power or Company), a division of PacifiCorp, submits the following tariff sheet applicable to Pacific Power's electric service in the state of Washington in compliance with RCW 80.28.050, WAC Chapter 480-80, and the Washington Utilities and Transportation Commission's (Commission) Rules and Regulations. The Company respectfully request an effective date of February 1, 2018.

Second Revision to Sheet No. 93.1 Schedule 93 Decoupling Revenue Adjustment

In this filing, the Company proposes its first adjustment for the decoupling mechanism that was approved by the Commission in Docket No. UE-152253. As outlined in Schedule 93, after applying the prescribed earnings test, rate trigger, and rate cap from the mechanism to each decoupled class, the Company has determined that a price change is necessary only for Schedule 40 customers. Attachment B shows the monthly results of the decoupling mechanism including each decoupled class' deferral for the first year period which was from September 15, 2016 through June 30, 2017. The Company proposes collecting \$464,117 from Schedule 40 customers through a 0.288 cents per kilowatt-hour surcharge. Attachment C shows the calculation of this proposed surcharge. Attachment C also shows the deferral remaining in the balancing account for each decoupled class. Attachment D shows that this proposed price change represents a 3.2 percent increase for Schedule 40 customers and a 0.1 percent overall increase for all of the Company's Washington customers.
