Dear Mr. King,

Pursuant to RCW 80.28.060 and WAC 480-80-101 and WAC 480-80-105(1)(c), please find enclosed for filing the following proposed revisions to the WN U-60, Tariff G for electric service of Puget Sound Energy (“PSE”):

**7<sup>th</sup> Revision of Sheet No. 142 – Schedule 142, Revenue Decoupling Adjustment Mechanism**

The purpose of this filing is to correct a scrivener’s error in the Delivery Revenue Per Unit for Rate Group 1 in electric Schedule 142. The current amount inadvertently transposes two digits. It is now corrected with this filing consistent with the intention of the original filing and associated work papers, despite the typographical error on the tariff sheet.

To allow for month-end decoupling deferral calculations to occur in a timely and accurate manner, PSE is requesting less than statutory notice approval for this filing. Therefore, PSE respectfully requests that the Commission allow this tariff change to become effective on January 26, 2018 with less than statutory notice (“LSN”). The information required by WAC 480-80-122 is contained throughout this letter and on the attached LSN form provided by the Commission. Ken Johnson is authorized to issue tariff changes on behalf of PSE.

The tariff sheet described herein reflects an issue date of January 11, 2018, and an effective date of February 11, 2018. Posting of proposed tariff changes, as required by law and the Commission’s rules and regulations, is being completed through web, telephone and mail access in accordance with WAC 480-100-193.
