Pursuant to RCW 80.28.060 and Chapter 480-80 WAC, please find enclosed for filing the following proposed revision to the WN U-60, Tariff G for electric service of Puget Sound Energy (“PSE”).

2nd Revision Sheet No. 139-E – Schedule 139: Voluntary Long Term Renewable Energy (continued) Attachment “A” – Service Agreement to Electric Schedule 139

The purposes of this filing are to update the Energy Charge Credit and to propose clarifying revisions to the Attachment “A” to Schedule No. 139, Service Agreement to Electric Schedule No. 139.

The proposed Energy Charge Credit change results from Order 08, Final Order Rejecting Tariff Sheets; and Authorizing and Requiring Compliance Filing, in consolidated Dockets UE-170033 and UG-170034 issued by the Washington Utilities and Transportation Commission on December 5, 2017, (“Order 8”). The proposed Energy Charge Credit reflects the energy portion of the power costs that are embedded in the retail rates as prescribed in paragraph 336 of Order 08, which consists 75% of the power costs.

The tariff sheet described herein reflects an issue date of January 26, 2018, and an effective date of March 1, 2018. Notice of the proposed tariff changes, as required by law and the Commission’s rules and regulations, is being given to the public immediately prior to or coincident with the date of this transmittal letter, through web, telephone and mail access in accordance with WAC 480-100-193(1). Posting of this proposed tariff change will be
