## TO ALL INTERESTED PERSONS:

On March 29, 2018, Puget Sound Energy (PSE), filed with the Washington Utilities and Transportation Commission (Commission) Draft Request for Proposals (RFPs) regarding All Generation Sources in Docket UE-180271, and Demand Response Programs in Docket UE-180272.

Proposed RFPs are required by WAC 480-107. WAC 480-107-015(3)(b) specifies that all interested persons shall be provided a 60-day public comment period for written comments on RFPs. Following the comment period the Commission has 30 days after the close of the comment period to approve or suspend the RFP filing.

Written comments must be filed with the Commission no later than **May 29, 2018**. The Commission requests that comments be provided in electronic format to enhance public access, for ease of providing comments, to reduce the need for paper copies, and to facilitate quotations
