Dear Mr. Johnson:

Attached for filing is a Request for Cancellation of the Registration of Crown Castle NG West LLC ("CCNG-West") was granted in Docket No. UT-050988. As described in Docket No. UT-180980, the Washington operations and assets of CCNG-West were consolidated into its affiliate Crown Castle Fiber LLC on December 31, 2018, and CCNG-West therefore no longer provides telecommunications services in Washington. All of CCNG-West's Washington customers are now served by Crown Castle Fiber LLC pursuant to its Registration granted in Docket No. UT-180912. Accordingly, CCNG-West does not require its Registration and the Commission should cancel it effective January 1, 2019 or the earliest possible date.


