IMPORTANT NOTICE

Dear Water Customer,

This letter is to inform you of Northwest Water Services, LLC has requested to the Utilities and Transportation Commission for consideration of a temporary capital surcharge. This surcharge is requested based on the installation of a new treatment plant at Silver Lake Water system. The system currently experiences high levels of Manganese and Iron in the water which is naturally occurring. This treatment system will help reduce the amount of those minerals in the water which will reduce staining in fixtures and eliminate the need to flush the system each month. This higher quality of water will ultimately bring higher values to your property. The initial cost of this requirement is in excess of \$70,000 and this surcharge is proposed to cover about 70 % of the cost. There will be an increase to the surcharge or lump sum payment once the final installation is complete and all costs are accounted for. Additional notices will be sent prior to any increase in this surcharge. If the commission agrees with our request the capital surcharge would be in effect April 14, 2019 and expire on April 30, 2024. The suggested monthly charge is \$4.52 per customer. If you would like to pay the surcharge in full the lump sum payment is \$212.59 per customer. If you have any questions please call Northwest Water Services at 360-306-3692.
