Dear Mr. Kazen,

Having verified the 2018 solid waste collection information provided by Sunrise Disposal, Inc., Waste Management of Greater Wenatchee and Zippy Disposal, Inc., it is now possible to confirm and bill for the 2019 Douglas County Solid Waste Collection Fee.

According to the information provided and verified, Waste Management of Greater Wenatchee collected 94.330% of the total solid waste volume, both commercial and residential, collected within **the unincorporated area of Douglas County in 2018**. Using the formula agreed to in the adopted *Douglas County Solid Waste Collection Fee Ordinance, C.E. 94-014*, I have computed your actual 2019 Douglas County Solid Waste Collection Fee amount to be **\$188,625.26**. This amount is your 'fair share' portion of the adopted 2019 Solid Waste Program Budget of \$199,963.00, multiplied by your reported percentage of the 2018 unincorporated Douglas County solid waste volume. Your 'fair share' portion of the 2019 Solid Waste Program Budget will be billed out on a quarterly payment basis. I have enclosed a billing schedule which illustrates how your 'fair share' percentage was determined, when to expect to be billed, how much you will be billed and when each payment is due. Please pay your first quarter Douglas County Solid Waste Collection Fee in the amount of **\$47,156.32 by March 15, 2019**.
