This filing deletes Private Switch/Automatic Location Identification (PS/ALI) and all associated language and rates. The contract awarded to Comtech by the State of Washington includes routing and ALI Database management. CenturyLink has been working with PSAPs on the migration to Comtech. To date, CenturyLink has continued to perform Selective Routing and ALI Database management. Effective May 8, 2019, CenturyLink will no longer provide the selective routing function or offer PS/ALI. CenturyLink will include existing records in the database migration to Comtech; however future updates, additions, moves, changes, and deletions must be handled by the PSAP directly with Comtech.

Customers who currently subscribe to CenturyLink QC's PS/ALI service were notified via direct mail at least 30 days prior to the date on which CenturyLink will discontinue providing these functions. A copy of that customer notice was provided with the CenturyLink QC tariff revisions that were separately filed.
