Dear Mr. Johnson:

Attached you will find the above-referenced tariff page. The purpose of this filing is to seek a general rate increase on behalf of Rainier View Water Company, Inc. (the "Company") Attached is a copy of the customer notice that was mailed to the customers on May 31, 2019.

The purpose of this filing is to seek rates that cover the Company's increased operating costs, which are primarily employee wage increases and insurance increases.

This filing requests an increase in Company annual revenues of \$641,339. This represents a 9.01 percent increase in the Company's annual revenues. The first usage rate block for all meter sizes would increase from its existing rate of \$1.00 to \$1.15 (15%). The second usage rate block for all meter sizes would increase from its existing rate of \$1.15 to \$1.55 (34.78%). The third usage rate block for all meter sizes would increase from its existing rate of \$2.42 to \$3.03 (25.20%).

The Company is submitting the work papers as required by WAC 480-07-530. The Company has completed a rate matrix, copy attached. This includes some of the material required by WAC 480-02-530(4) (calculation of revenue impact, statement of revenues and expenses and restating and proforma adjustments). Usage statistics, a depreciation schedule and balance sheet are also attached.



The salaries are included in the statement of revenues and expenses.

The filing affects all water systems operated by the Company. The Company has previously provided the public water system identification numbers for each system.
