This transmittal letter including 3rd revision of pages 2 Check List and 30 Item 230 necessary due to our disposal rate increase at Cowlitz County Landfill.

On January 1, 2020, the disposal rate is increasing 9.39% from \$51.02 per ton to \$55.81 per ton. Based on 2018 tonnages, the estimated increase in revenue and pass thru for drop box customers would be \$930. We have no permanent drop box placements to notify of the impending rate increase.

We are requesting LSN handling per WAC 480-70-262 and 480-70-271 for these tariff changes to be effective January 1, 2020.

There are no proposed tariff rate changes at this time other than the drop box pass thru. We anticipate filing a Tariff rate case next year after finalizing our 2019 year operations data needed for the proforma basis.

SUBJECT: Notice of Solid Waste Disposal Rate Increase Effective January 1, 2020

Dear Mrs. Stanley,

Please accept this written correspondence of Cowlitz County's intent to raise solid waste disposal rates effective January 1, 2020. Attached is a copy of the disposal rates schedule going into effect at that time. Rates will increase 9.39% and go from the current \$51.02 per ton to \$55.81 per ton for disposal at the Third Avenue Transfer Station.

The intent of this letter is to comply with requirements of **RCW 70.95.212 Solid Waste Collection Companies—Notice of changes in tipping fees and disposal rate schedule**. State law requires the county to provide you with a minimum of 75 days-notice before rate changes are brought into effect. This rate increase is brought about by the County's need to stay current with inflation costs experienced over the past 2 year period. The rate increase is allowed by Cowlitz County Ordinance 15.34.030.
