Cascade Natural Gas Corporation (Cascade or the Company) files herewith the following revisions to its Tariff, WN U-3, stated to become effective with service on and after April 20, 2020:

Within this filing, the Company is withdrawing from Tariff WN U-3 the following *current* sheets:

Original Sheet No. 583

The Company is submitting this housekeeping filing to address technical changes to the Company's tariff sheets that were not included in or affected by the Company's last general rate case docketed as UG-190210. The Company's rate case concluded with Order No. 05 and the resulting rates became effective on March 1, 2020. The Company now seeks to make housekeeping changes to the sheets that were either suspended in the rate case filing or were affected by the filing.

The majority of the enclosed revisions are being made on Sheet 595, Temporary Technical Adjustment. The proposed rates listed on Sheet 595, Weighted Average Cost of Gas (WACOG), are designed to transfer the proposed rates to update the current WACOG to the affected schedules above and zero out Sheet 595. No proposed changes in rates have been made.
