- Note 1: Customers will be charged for service requested even if fewer units are picked up on a particular trip. No credit will be given for partially filled cans. No credit will be given if customer fails to set receptacles out for collection.
- Note 2: For service more frequently than weekly, multiply the above rates by the number of times per week service is required.
- Note 3: A re-delivery fee of **\$16.60** will be assessed to cart customers whose service is discontinued for non-payment or cart customers who request re-delivery.
- Note 4: For those customers who do **not** receive garbage services add **\$1.50** to the rates above for both recycling and yard waste services.
- Note 5: Effective September 1, 2017 can service will no longer be available to new customers. Existing can customers may continue to use their cans at the applicable tariff rates until such time that they choose to change their service. At such time, can customers will be required to subscribe for cart services provided for in the tariff.
