This is to notify you of a proposed rate change for residential waste and recycling services in the Towns of Twisp and Winthrop, WA and portions of Okanogan County where Methow Valley Sanitation Service, Inc. d.b.a. WasteWise Methow (the Company) operates. Should the Washington Utilities and Transportation Commission (the Commission) approve this case, customers will experience a rate increase throughout all classes of service effective June 1, 2020.

It has been six years since the Company's last general rate case. In that time, the Company has absorbed cost increases in key areas including workforce and maintenance. In addition, it is necessary at this time for the Company to replace key equipment to ensure the safest, most reliable service possible. Declines in recycling markets since 2018 make it necessary to increase recycling rates to cover the cost of collection and material processing.
