Cascade Natural Gas Corporation (Cascade or the Company) files the following revisions to its Tariff, WN U-3, stated to become effective with service on and after August 31, 2020:

Seventy-Ninth Revision Sheet No. 500

The purpose of this filing is to revise the city tax for Burlington from 3.0% to 6.0% starting August 31, 2020. The City adopted this change in Ordinance No. 1890 which will result in each customer in Burlington experiencing a 3% increase in their monthly bills.
