**Re: TV-210013- Voluntary Cancellation of THG069211** and Dismissal of Permanent Application TV-200417

Dear Peckham, Kayla M:

On January 7, 2021, Peckham, Kayla M, d/b/a Anything & Everything Movers Anything & Everything Moving, requested that the Washington Utilities and Transportation Commission (Commission) cancel its permit because Peckham, Kayla M is no longer operating due to economic conditions relating to the COVID-19 pandemic.

Based on the request, the Commission **cancels** THG069211 and dismisses the permanent application TV-200417. Peckham, Kayla M must **cease** all operations associated with this permit. If you advertise or operate as a household goods mover without a valid permit, the commission may take enforcement action against you.

Please note: You must submit an annual report for that portion of the year in which your company operated. You must also pay the annual regulatory fee if you discontinue operations after the reporting year ends (December 31).
