Dear GreenHopper Movers Limited Liability Company:

On February 8, 2021, GreenHopper Movers Limited Liability Company, d/b/a GreenHopper Movers LLC, requested that the Washington Utilities and Transportation Commission (Commission) cancel its permit because GreenHopper Movers Limited Liability Company is no longer operating due to the economic conditions associated with the COVID-19 pandemic.

Based on the request, the Commission **cancels** THG069288 and dismisses the permanent application TV-200609. GreenHopper Movers Limited Liability Company must **cease** all operations associated with this permit. If you advertise or operate as a household goods mover without a valid permit, the commission may take enforcement action against you.

Please note: You must submit an annual report for that portion of the year in which your company operated. You must also pay the annual regulatory fee if you discontinue operations after the reporting year ends (December 31).
