## IMPORTANT NOTICE

Camano Hills Water System has asked the Washington Utilities and Transportation Commission (UTC) for authorization for a general rate change and to update the tariff. If approved, the new rates will become effective April 15, 2022. Your rates have not been increased since 2015, yet throughout this time there have been significant repairs and improvements within the system including pump replacements, and new automatic transfer switch for the generator..

This increase in water rates will only begin to partially recover over time what has been spent to bring clean safe water to your homes. The company revenue impact of this filing, based on a 2021 test year, will be an increase of approximately \$106,000 (53%) over a period of two years and four phases of rate changes. Phase 1 is effective April 15, 2022. Phase 2 is effective October 1, 2022. Phase 3 is effective April 1, 2023. Phase 4 is effective October 1, 2023.

The water treatment surcharge currently in place at \$4.14 per month per connection or customer will remain the same. This surcharge expires December 30, 2030 upon recovery of the \$206,881 DWSRF Loan which was borrowed to fund capital improvements for our existing water system.

Usage blocks are in cubic feet. Rates are per 100 cubic feet. 1 cubic foot equals 7.5 gallons
