NOTICE OF PROPOSED RATE CHANGES FOR 2" METERED CUSTOMERS

Great Basin Water Company LLC has asked the Washington Utilities and Transportation Commission for permission to increase the water rates we charge all our customers. The proposed rates will increase annual revenues to the company by approximately \$108,205 (32%) per year to cover increased operating expenses of labor, insurance, fuel, electricity, etc. . If approved, the new rates will be effective on May 1, 2022. The rate increase will be based on water used after April 30th, and reflected on your May 31, 2022 billing.

Below is a table showing the current and proposed water rates for 2" meters (cu ft = cubic feet):

Base Rate (zero cubic feet of usage)	\$143.91
0-5,330 cu ft per 100 cu ft	\$1.00
5,330-17,637 cu ft per 100 cu ft	\$2.00
Over 17,637 cu ft per 100 cu ft	\$3.00

One cu ft = approx. 7.48 gallons of water

Below is a list of changes to other fee charges that may affect you:

NSF Check Charge	\$9.00	\$9.00
Service Connection Charge	\$600.00	\$1000.00
Water Availability Letter Charge	\$20.00	\$20.00

\*The late payment charge is a minimum of \$5.00 or 2% of the delinquent balance, whichever is greater. Payment is considered late 15 days after the water bills are mailed to you.

The commission has the authority to set final rates that may be either lower or higher than the company's request, depending on the results of the investigation.
