Dear Ms. Maxwell:

Pursuant to RCW 80.28.060 and WAC 480-80-101 and WAC 480-80-105(1)(c), please find enclosed for filing the following proposed revision to the WN U-60, Tariff for electric service of Puget Sound Energy ("PSE" or "the Company"):

2nd Revision of Sheet No. 80-R.1 - Schedule 80 General Rules and Provisions (Continued)

4th Revision of Sheet No. 80-Z.1 - Schedule 80 General Rules and Provisions (Continued)

The purpose of this tariff revision is to allow PSE to suspend its collection of its reconnection charge and disconnection visit charge until thirty days after the Commission issues its order adopting rules or otherwise determines these charges in Docket U-210800.

In addition, on March 29, 2022, the Commission issued Order 06 in Docket U-200281, which 1) waives all late fees for residential customers, and exempts residential deposit requirements in WAC 480-100-113 until thirty days after the Commission issues its order adopting rules or otherwise determines the fee and deposit rules in Docket U-210800; and 2) replaces the Third Revised Term Sheet COVID-19 Response ("Term Sheet"), Section C – Fees, adopted by the Commission in Order 03 and extended by Order 04 in Docket U-200281 with the Fourth Revised Term Sheet COVID-19 Response.

PSE respectfully requests that the Commission allow these tariff changes to become effective on March 31, 2022, with less than statutory notice ("LSN") so that they can go into effect immediately upon the expiration of the Third Revised Term Sheet on March 30, 2022. The
