Jon, here is an attachment of the water service which was pulled by Allied Resource Group. Please add this to information what you already have for Case 21-051.

This is a brief narrative to be used as a companion to my existing main narrative as the original has timeframe/date info. If you recall our earlier Zoom conversation, Richard Coe alleges he was "not digging" when the 1" service was pulled. He mentioned he was simply putting rock down for a driveway path, likely for initial construction needs. If this is the case then how is it that the 1" copper service/stop valve is exposed and the soil under is about 12" deeper than edge of concrete alley panel?

You'll also note there is no blue locate marks across the alley indicating its location, we never had a chance to locate the service which was know on the plan set to be abandoned at a later date. As mentioned in the main narrative, no locate was called in. While he indicated that no work was being doing particularly in the right of way and that work was being done only on the private side he's incorrect. Water meters are at property line and ARG exceeded that location to the alley edge. Richard needs to call in locates regardless of public or private as some utilities extend up to homes through private property or via easement... Examples, PUD secondary power or gas service/meters or water main fire lines via easement from alley between houses to fire hydrants on the front street. The latter also being one of our particular examples.

We installed a new "temporary ball valve" to stop the leak. It was not readily apparent but the service was also leaking at the threads of the water main corp stop. This line was scheduled to be abandoned per City standard plan at a later date as indicate above and which typically means turning off the corp valve and cutting the service loose. In this case we had to shut down the water main, remove the direct thread corp valve and install a full circle repair clamp at a different pre-planned date approved by the City.

The second sentence in 19 122 070 2 says that treble damages can be assigned to an excavator who willfully damages a facility without calling for locates. Not calling for locates is considered a willful act and applies in this case. I'm personally not a fan of treble damages unless a third party determines a violation occurred rather than a facility operator. In your case, I think 070 2 would apply to 21051 after review but not 22-003. Hope this helps. Call me if you have any questions or want to discuss further.
