SPECIAL FUEL SURCHARGE SUPPLEMENT NO. 1

Applies on Carrier's Tariff No. 12

The Commission approves a temporary 3.46% fuel surcharge in all rates and charges as a result of increased fuel costs incurred by the company during the months of May, June and July 2022, to be collected from customers as a separate line item on the billing, as follows:

Customers who are billed monthly for services in arrears:

The fuel surcharge applies to all services provided in the months of August, September and October 2022.

Customers who are billed quarterly for services – Current month and two months in advance:
