* Explain why the company is proposing this tariff revision: Pend Oreille County Solid Waste increase going into effect June 1, 2023
* Explain why the Commission should allow this tariff revision to take effect with less than 30 days' notice (45 days' notice for solid waste): I transposed the dates for the rate increase from Pend Oreille County (thinking it was August 1, 2023 vs June 1, 2023).
