In accordance with Order 02, Docket No. TG-210912, the Company is now submitting a general rate case today but seeks exemption under WAC 480-07-110 to file and serve its customer notice letter pursuant to WAC 480-70-271 within 30, not 45 days as authorized by rule, so as to finalize the featured rate spread and produce updated calculations on the full range of tariff impacts by customer service level.

**\* Explain why the Commission should allow this tariff revision to take effect with less than 30 days' notice (45 days' notice for solid waste):**  
This request is fully consistent with the public interest in allowing a modicum of additional time to enhance the comprehensiveness, specificity and accuracy of the customer notice correspondence pertinent to this filing.
