**RE: Bremerton Rate Center Numbering Waiver**

Dear Ms. Hunter:

By this letter Teleport Communications America, LLC (“TCAL”), OCN 7146, is requesting a waiver of the utilization and months-to-exhaust requirements outlined in FCC’s Numbering Resource Optimization Orders, FCC 00-429 and FCC 01-362 released in CC Docket No 99-200, which would allow the Pooling Administrator (PA)/NANPA to assign 65 thousand blocks to TCAL to meet the needs of a specific customer.

Specifically, the customer has requested 65,000 telephone numbers in the Bremerton Rate Center for the DoD dial plan supported by PEO-Digital for migration of a new platform without impacting operations for the customer's service members, supporting civilian and contract staff. The customer’s Letter of Intent is attached as **Confidential Exhibit A** and has been redacted pursuant to WAC 480-07-160. TCAL cannot satisfy this request from its current numbering inventory.

Although AT&T has an adequate supply of telephone numbers to satisfy incremental requests for numbers without receiving a new block, AT&T’s existing numbering resources cannot satisfy the need for 65,000 numbers in the 564-area code. Thus, on October 16, 2023, AT&T submitted a Thousands Block Application Form Part 1A and a MTE and Utilization Certification Worksheet – TN Level to the Pooling Administrator (“PA”) for sixty-five one thousand blocks in the Bremerton rate center. The Pooling Administrator System (“PAS”) denied AT&T’s request because AT&T did not meet the Months to Exhaust (“MTE”) and/or Utilization requirements.

In our effort to satisfy the customer’s request, TCAL submitted a request to PA/NANPA on October 16, 2023, for additional numbering resources. That application Form 1A, the MTE/Utilization Worksheet and the subsequent denial are attached as **Confidential Exhibit B**. In order for the request to be approved, TCAL requires a waiver of the current month-to-exhaust and utilization thresholds for new numbering requests. Month-to-exhaust was in scope but did not meet the rules qualification; utilization was 50.9%.

Note that information is redacted in both Exhibits A and B as both Exhibits include trade secrets that are not available to the public.

The FCC allows for a waiver of the rules when there is demonstrated need such as a specific customer request for a large block of numbers. The waiver process is specifically addressed in the FCC Third Report and Order (“Order”) as the “safety valve” process (See FCC 01-362, 57-66), which went into effect on March 14, 2002. The order delegates the authority to hear claims for waivers to the state commissioners and recommends that state commissions act expeditiously. The Order proposes that state commissions review a waiver within 10 business days. (See 61, 66).

TCAL respectfully requests that the Commission approve the request for a waiver of months to exhaust and rate center utilization requirements and direct PA/NANPA to accommodate our customer’s request.

is in the process of modernizing communications capabilities at [REDACTED] Bremerton, WA 98314, based upon [REDACTED] which include migration to Voice over Internet Protocol (VoIP) access for commercial voice services. AT&T has been selected as the local services provider for VoIP Trunking services and an order has been placed for the equivalent of 40 PRI(s) in concurrent call capacity along with a request for a block of 65,000 new contiguous telephone numbers.

The service address for these numbers will be, [REDACTED] Bremerton, WA 98314, which is in the BREMERTON rate center.

The requested block of 65,000 contiguous public telephone numbers is required for compatibility with the existing [REDACTED] and to support migration to the new platform without impacting operations. Furthermore, [REDACTED] directly supports the [REDACTED] and the public interest as its primary customers.

is requesting that a block of 65,000 contiguous Direct Inward Dialing (DID) be allocated to AT&T to accommodate the requirements of this project. [REDACTED] targets completion of this project by October of 2023. The support of AT&T in issuing the requested 65,000 block is critical to achieving this goal.

The requested [REDACTED] will be direct extension dial. In addition, there will be a tremendous use of [REDACTED] for applications such as Teams collaboration, voice conferencing, ad hoc calling, voicemail, etc. There's no intent of returning any of the [REDACTED] as all of the numbers will be allocated for use. Pending AT&T's successful completion of testing, [REDACTED] understands these numbers will need to be activated within 180 days of the effective date.

A non-contiguous [REDACTED] range or a block of fewer numbers will seriously impact [REDACTED] operational capabilities for the [REDACTED] service members, supporting civilian and contract staff. If the Commission is not able to assign a new contiguous 65,000 DID block, we will not be able to align our dial plan to [REDACTED] standards which will have an adverse impact on [REDACTED] operations, training, and support.
