Due to increases in wages, transportation, and other operating costs, we have filed with the Washington Utilities and Transportation Commission (UTC) for a 6.72% overall rate increase. Our last general operating increase occurred in March of 2023. If approved, the proposed rates below would become effective January 1, 2025.
