Gary's Garbage Services, LLC has filed a proposed rate change case with the Washington Utilities and Transportation Commission. If approved, customers will experience a rate increase in the classes of service listed below.

Other services not listed will increase on average by approximately 14.49%. We are asking for these rates to become effective on January 1, 2025. Customers with dumpsters ranging in size from 1 – 8 yards will change from “once a month” service to “every other week” service, unless a more frequent service schedule is requested. Our last general rate increase was effective Aug. 25, 2022. Since that time, the Company has experienced increases in all expenses, including but not limited to fuel, insurance and operations.
