**SCHEDULE 141A
ENERGY CHARGE CREDIT RECOVERY ADJUSTMENT**

APPLICABILITY: This schedule is applicable to the electric energy delivered to any Customer except one, a) who has entered into a service agreement and taken service under the optional electric Schedule 139 Voluntary Long Term Renewable Energy Purchase Rider on or before the effective date of the original sheets of this schedule, or b) who is served under Schedules 448, 449, 458, or 459, or c) who is served under a special contract.

PURPOSE: This schedule implements a surcharge to recover certain costs incurred under the electric Schedule 139 Voluntary Long Term Renewable Energy Purchase Rider. The surcharge in this schedule recovers the costs of the Schedule 139 Energy Charge Credit associated with the energy-related power cost component of the Energy Charge of a Customer's Electric Service schedule. The surcharge in this schedule will be updated with each revision to the Schedule 139 Energy Charge Credit.

TRUE-UP: The Company will submit an annual true-up filing on or prior to the last day of November for rates effective on January 1 of the following year. The initial rates will be set as authorized under Docket UE-220066. Each annual true-up filing will set rates effective January 1 through December 31. The true-up will compare the amounts credited in Schedule 139 through the Energy Charge Credit, to the amounts collected through this schedule during the current year.




