Dear Mr. Johnson:

The purpose of this filing is to revise Toledo's 911 Tariff to move to Next Generation (NG) 911 service. The tariff changes for 911 NG service are very similar to those that have been put in place for the TDS companies.


Although Sheet 17 moves to an ICB form of pricing, the intent is to keep the bill for 911 service at its current level at the present time. A copy of the tariff changes are being sent to the attorney for the state 911 office.

The tariff filing is being made on greater than thirty days notice. The cut-over of service
